Travel Assistance Policy

We are pleased to offer travel assistance for Foraker Partners attending the 2023 Leadership Summit who live outside the Anchorage/Mat-Su area. Because funds are limited, please review the criteria below to determine if you or a member of your organization is eligible.

Deadline for applying for assistance is **Friday, March 24**.

You will be notified no later than **Friday, March 31**, if we are able to assist you. Again, funds are limited and we may not be able to accommodate everyone who applies.

Criteria for Travel Assistance

Applicants must be current Foraker Partners. A limit of two awards will be made to any organization. Both board members and staff are eligible. Priority will be given to those who work or serve on the board of a small or grassroots nonprofit, and individuals who work or serve on the board of a rural organization.

Assistance will include **one free night** at the Marriott and a **stipend toward airfare or mileage**. You may apply for lodging or a stipend toward airfare – or for both.

Note: You will need to make your own reservations at the Marriott. We will provide you will a promotional code.

The amount you will receive for airfare or mileage depends on your location. These amounts are determined by the cost of airfare normally associated with a given community.

- For people coming from Kenai Peninsula or Fairbanks – a maximum of \$300.
- For people coming from Prince William Sound, Coastal communities or Kodiak – a maximum of \$350.
- For people coming from Southeast, Western, or Northern Alaska – a maximum of \$550.

Reimbursement for airfare up to the amount listed above will be issued at the Summit upon receipt of a copy of your airline ticket. Reimbursements will be made to the organization, not to an individual.
